This report is based on donor records and excludes contributions in process at the reporting date, and includes contributions such as the sponsor portion of Matching Grant contributions that are not recognized as contribution revenue on the financial statements as required by U.S. accounting standards. Restricted includes PolioPlus contributions. PolioPlus contributions are \$101,259,974.53 through November 2007, and \$736,268.66 through November 2006. The \$100 million PolioPlus contribution from the Bill and Melinda Gates Foundation is included in restricted contributions for the USA and Canada.
